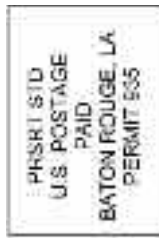

## LOCATION

- LSU Natatorium is located at Nicholson Dr. and West Chimes Street, just North of the LSU Football Stadium.
- Check-in will be held in the lobby prior to the start of camp, from 2:00-2:30 pm.
- Day campers will be dropped off and picked-up from the lobby of the Aquatic Complex each day.

## SPECIAL NOTES

- Airport pick-up/drop-off is available to and from Baton Rouge Airport (BTR) only for a \$15 fee. Please note on your registration you would like airport pick-up for your camper.
- Day Campers may opt to stay through dinner for the evening activity and be picked-up at 8:30pm. Cost \$75 for the week.
- **DISCOUNTS**
  - \$10 discount per camper for teams of 10 swimmers or more. For team discount contact Aimee Schmitt, Camp Director (tigerswimcamp@aol.com).
  - Full payment due by May 1, 2009.
  - \$15 discount is available to the second (or third) child in the family.
- **DEPOSIT**
  - A \$100 non-refundable deposit is due by May 1, 2009 and full payment thereafter by June 1, 2009.
  - Deposit is not necessary if you pay in full, however your place will be held with a \$100 deposit.
  - Staff members reserve the right to the final decision regarding placement of swimmers in levels according to age and ability.
  - Upon receiving your registration, a confirmation packet which includes detailed information will be sent via email. A completed packet is a prerequisite for participation in Tiger Swim Camp 2009.

## REFUND POLICY

- Cancellation between May 1, 2009 and June 1, 2009 entitles campers to a 50 % payment refund (excluding non-refundable deposit).
- Cancellation after June 1, 2009 results in no refund.
